

2012 **Cheektowaga Art Guild's 48th Annual Outdoor Arts & Craft Show** 2012

A successful show depends on your cooperation. Please read and follow the *Rules of the Show*:

1. This year, the Arts & Craft Show will be held on both sides of the Cultural Center in the Lion's Pavilion and shelter areas one, two and three*.

2. On Saturday July 14th & Sunday July 15th there is to be no set up before 8:00 a.m. Exhibitors must be registered before they set-up. *The registration desk will remain open from 8 a.m. until 10 a.m. You must register before you set-up. Exhibit space will be on a first come, first served basis. No exceptions. ABSOLUTELY NO VEHICLES ALLOWED IN THE EXHIBITION AREA BEFORE 5 p.m.!!!*

3. Your entry fee allows you a fifteen by eight foot (15'x8'), single, one sided fence space, or a 12'x12' single tent/canopy space. More space can be acquired for an additional fee. Exhibitors *must* stay within their allotted space. [Walkways *must* be kept open for safety purposes.] Only ONE exhibitor may occupy a single space. **NO KITS OR VENDORS ALLOWED. NO COMMERCIAL PRODUCTS MAY BE SOLD.**

4. The Guild reserves the right to deny entry to any works or exhibitors in order preserve the integrity of the organization and exhibition.

5. Exhibitors must be present at their exhibits at all times. If you must leave your area, do not leave it unattended. Each artist/crafter is responsible for his or her own original works. (The Cheektowaga Art Guild is not responsible for theft or damages.) We recommend obtaining a sales tax certificate if you wish to sell your art or craft.

6. Exhibitors may exhibit both days, or only one. Judging will be at 1 p.m. on Sunday only. **Artists:** Each judge will select one work of art for final judging. **Crafters:** Will select their work to be entered for judging. Arts & Crafts are judged separately. All works to be judged must be the original creation of the exhibitor. No kits are allowed.

7. To be eligible for judging, **All** works of **Art** must be properly framed and securely wired according to the Exhibit Chairman's standards. **Crafters:** Must provide their own ground cover for works taken to the judging circle. The Art Guild is not responsible for soiling or damage.

8. Each exhibitor is eligible for only one award. Prize winners must be present to accept their award at the end of the show, or forfeit the same. Again, all work(s) exhibited must be the original creation(s) of the exhibitor. The Exhibit Chairman will have final say in this matter and all decisions are final.

9. All exhibitors are responsible for clean up of their areas. Trashcans will be provided. No glass bottles or containers will be allowed in the park. Violators will be asked to leave.

* Exhibition on both sides of the park depends on the number of exhibitors registered and is subject to the Exhibit Chairman's discretion.
